• Tell Hamilton is the Executive Director and also IACC Planner for this Tribal Broadband & Digital Equity Breakout:


#### Mike Mason

Mike has spearheaded the retail enterprise for the Nisqually Tribe. Mike has extensive background and hands on experience in all phases of retail development; inter-governmental relations; community development project planning and management, and fundraising.
- Mike worked on bringing internet to the reservation with the IT Director. Though the CERB feasibility grant, Nisqually was able to run fiber optic though out the reservation and is now giving 1 Gig to its members. With the success of Broadband on the reservation. The Tribe has made the priority of bringing broadband to the underserved to the communities in Thurston and Pierce Counties.
- Mike has always worked with programs that put Native communities forward. To progress the Tribal communities in day to day life.

- Ernie Rasmussen, Citizen of the Oneida Nation of Wisconsin, is currently serving as the Executive Director for Bigfoot Telecommunications of the Confederated Tribes of the Colville Reservation in North Central Washington.

- Mr. Rasmussen has spent his entire 20+ year career in service to Tribes, including as Tribal Liaison at WA Commerce, Digital Equity Manager at WSBO, Senior Planner of Economic Development for the Confederated Tribes of the Colville Reservation, Executive Director of a 501c3 on the Spokane Indian Reservation, a College Math Instructor at a Tribal College, and a GED instructor.
- Mr. Rasmussen holds a BA in Interdisciplinary Studies from Eastern Washington University, a Master in Urban & Regional Planning candidate and is a committed advocate, ally, and accomplice in the creation of Tribal Communities as Communities of Choice to live, work, and thrive!
- His wife is a Spokane Tribal member and together they have 3 beautiful and supremely talented daughters and one 3 year old very VERY cool grandson offering a chance to relive the age of dinosaurs.
